## OKTAGON FANTASY

Welcome to **OKTAGON Fantasy** (“**OKTAGON Fantasy**”) – the official MMA Fantasy Competition of OKTAGON. Draft your Fighters, for each OKTAGON Tournament during the Draft Window, with the option to predict Fighter’s method of victory. After the OKTAGON Tournament, OKTAGON scores predictions based on official results, awarding Points for performances and bonuses for accurate calls. Points accumulate across the season, unlocking Ranks and new features, with the top goal of becoming the OKTAGON Fantasy Champion.

# OKTAGON FANTASY

In these OKTAGON Fantasy Rules (“**Rules**”), any use of the words “**you**”, “**your**” or similar expressions refers to any registered player of OKTAGON Fantasy. Terms such as “**OKTAGON**”, “**we**”, “**us**”, “**our**” or similar expressions refer to the organizer of OKTAGON Fantasy – 2NP Production s.r.o., ID No. 060 14 054, with registered office at Přívozní 1600/2b, Holešovice, 170 00 Praha 7.

## GLOSSARY

The following terms are used throughout the Rules. Please refer to this glossary whenever you need clarity on specific OKTAGON Fantasy terms or phrases:

- **Account** = A personal OKTAGON Fantasy profile registered by a Player, used to access the OKTAGON Fantasy, draft Fighters, and receive Rewards.
- **Draft** = Your OKTAGON Tournament selection of Fighters (including any optional predictions or picks).
- **Draft Window** = The period when Players can pick Fighters and/or change their Draft: Wednesday 13:00 → Saturday 16:00 (local time of the OKTAGON Tournament). Alternative Draft Window times may apply for OKTAGON Tournaments which are not held on a Saturday. The applicable Draft Window is always visible on the homepage of OKTAGON Fantasy for the respective upcoming OKTAGON Tournament and communicated through official channels.
- **End of Draft Window** = Saturday 16:00 (local time of the OKTAGON Tournament), or such other time as may apply for OKTAGON Tournaments not held on a Saturday. After End of Draft Window, no changes to the Draft are allowed.
- **Fight Week** = The week of an OKTAGON Tournament (from Monday until Sunday for each OKTAGON Tournament).
- **Fighter** = An officially registered MMA athlete scheduled to compete in an OKTAGON Tournament, as published on the official OKTAGON website.
- **Leaderboard** = The public ranking of Players based on their total Points, updated after each OKTAGON Tournament.
- **Momentum Bonus** = A one-time +6 Points bonus that OKTAGON may award to new Players joining after the second OKTAGON Tournament of the Season (subject to the conditions below).
- **OKTAGON Tournament** = An official MMA event organised by OKTAGON and listed on the official OKTAGON website.
- **Points** = The cumulative total of all scoring awarded from your Drafts results in OKTAGON Fantasy.
- **Player** = Any registered user who participates in the OKTAGON Fantasy.
- **Raffle** = Rewards draw associated with Ranks or events; winners will be notified via Discord direct messages (if linked), verified email or another official communication channel designated by OKTAGON.
- **Rank** = Progress tiers unlocked by cumulative Points (Novice, Rising Star, Contender, Elite, Interim Champion, Champion) with associated Rewards.
- **Reward** = Any prize, benefit, or digital item (such as badges, avatars, merchandise discounts, tickets, or meet-and-greet experiences) awarded to a Player through

OKTAGON Fantasy based on their Rank, Points, or Raffle results. Rewards may be physical or digital and are non-transferable.

- **Season** = The full set of the current OKTAGON Fantasy Tournaments counted toward Ranks, Rewards, and the overall Champion.
- **League** = An optional special competition within OKTAGON Fantasy, operated by OKTAGON or in cooperation with a third-party partner, which may have its own rules, leaderboard, eligible tournaments, rewards, avatars, badges or other features.
- **League Leaderboard** = A separate ranking of Player's participating in a specific league, based on the Points counted toward that League.
- **League Draft** = A Player's Fighter selection used for a specific League. A League Draft may be based on the Player's main Draft or may be modified separately where permitted by the rules of that League.
- **League Rules** = Additional rules applicable to a specific League. League Rules may define eligible tournaments, entry conditions, draft rules, rewards, scoring application, retroactive points and other League-specific conditions.

## TERMS & CONDITIONS AND GAME RULES

### 1. Account and Registration

#### 1.1. Creating an Account

1.1.1. To participate in OKTAGON Fantasy, you must create an Account through the official OKTAGON Fantasy platform, accessible via the OKTAGON's website. You can sign in using your existing OKTAGON.TV account or create a free account using your email to get started. Alternatively, you can also create an account through selected third-party services, including Google, Apple, or Facebook.

1.1.2. During registration, you will be asked to provide certain required information, including unique nickname, gender, age, jersey size, country of origin and first and last name. During registration you will also be asked to accept these Rules.

1.1.3. By registering to participate in OKTAGON Fantasy, you agree with the full content of the Rules. You should read these Rules carefully before using OKTAGON Fantasy. These Rules apply on every occasion that you use OKTAGON Fantasy. If you do not agree or accept the Rules, you will not be able to access OKTAGON Fantasy.

#### 1.2. Changes to Registration Details

1.2.1. You are responsible for ensuring that the registration details linked to your Account remain accurate and up to date.

1.2.2. In the event of a forgotten password or loss of access to your Account, you must follow the official password recovery process available on the OKTAGON's Fantasy login page.

1.2.3. If you experience any difficulties in updating your registration details or restoring Account access, please contact our Customer Support at [customer.support@oktagonmma.com](mailto:customer.support@oktagonmma.com).

#### 1.1. Eligibility

1.1.1. To create an account and play OKTAGON Fantasy you must be at least sixteen (16) years old. If the laws of your country or region require a higher minimum age for online games or promotions, that higher age applies.

- 1.1.2. By participating, you represent that you meet the applicable minimum age. OKTAGON may request proof of age at any time and may suspend or close Accounts, or withhold prizes, until age is verified or until parental/legal guardian consent is provided.
- 1.1.3. Players under sixteen (16) years old (or any other minimum age requirement) must ensure parental or legal guardian assistance in registering or participating in OKTAGON Fantasy and to understand these Rules. Parents or legal guardians may be required to confirm their agreement with their participation in OKTAGON Fantasy and acceptance of any Rewards. Such confirmation shall also include the parent's or legal guardian's consent to accompany the Player during any prize-related travel and to comply with any other applicable prize conditions.
- 1.1.4. OKTAGON Fantasy is open to players worldwide, except for residents of countries subject to USA, UK, or EU sanctions (including, but not limited to, Russia and Belarus).

## 1.2. Requirements

- 1.2.1. Participation in OKTAGON Fantasy is completely free. No purchase is required to enter, and buying any item will not increase your chances of winning.

## 1.1. Account Security

- 1.1.1. You are solely responsible for maintaining the confidentiality of your login credentials, including your email, password, and any other information used to access your Account.
- 1.1.2. Sharing, transferring, or allowing others to use your Account is strictly prohibited. Each Account is personal and may only be used by the individual who registered it. Any activity carried out through your Account will be deemed your responsibility, whether authorised by you or not. Violation of these obligations may result in suspension or termination of your Account.
- 1.1.3. If you suspect that your Account has been compromised, lost, or accessed without your authorisation, notify our Customer Support immediately at [customer.support@oktagonmma.com](mailto:customer.support@oktagonmma.com). OKTAGON may ask you to provide additional information to verify your identity before taking any remedial action.

1.1.4. OKTAGON reserves the right to investigate any suspected unauthorised access, fraud, or misuse of Accounts. Depending on the severity of the case, OKTAGON may take actions including, but not limited to, temporary suspension, permanent termination, disqualification from OKTAGON Fantasy, or withdrawal of rewards. OKTAGON is not liable for any loss of points, prizes, or access resulting from your failure to maintain adequate security of your Account.

## 1.2. One-Account Policy

1.2.1. Each individual is permitted to register and maintain only one Account for participation in OKTAGON Fantasy. Creating or maintaining multiple Accounts is strictly prohibited.

1.2.2. If duplicate Accounts are discovered, OKTAGON reserves the right to suspend or permanently delete such Accounts. Any points or rewards earned through duplicate Accounts will cease to exist.

## 1.3. Inactive or Suspended Accounts

1.3.1. Accounts may be suspended or deleted in cases of extended inactivity, violation of the Rules, or other breaches of fair play.

1.3.2. Any attempt to cheat, manipulate results, or otherwise abuse the OKTAGON Fantasy and/or the Rules may result in immediate disqualification, loss of rank, permanent ban from OKTAGON Fantasy, and possible loss of access to the Account and to other associated services provided by OKTAGON.

## 1.1. Social Sharing Functions

1.1.1. OKTAGON Fantasy may include optional in-game functions that allow Players to share their game information (such as selected Fighters, Points, or Rank) on social media platforms. Use of these sharing functions is entirely voluntary. In order to utilise certain sharing functions, Players may be required to connect their relevant social media profiles to their Account.

## 2. Game Structure

### 1.1. Fighter Selection

1.1.1. Players draft up to three (3) Fighters every OKTAGON Tournament.

- 1.1.2. Players may optionally predict the method of victory (KO/TKO, Submission, or Decision) for which the Win Method Bonus (as defined below) applies.
- 1.1.3. From the Rank “Contender”, a 4th Fighter slot is unlocked, therefore you may draft up to 4 Fighters every OKTAGON Tournament. If you drop below the required points threshold and therefore fall back to a lower Rank, the 4th Fighter slot is removed, and you may only draft 3 Fighters until you regain Rank “Contender”.
- 1.1.4. If you have already submitted a Draft with 4 Fighters and subsequently lose the Rank “Contender”, your Draft will be automatically reduced to 3 Fighters. The last selected Fighter will be removed, and no points will be awarded for that Fighter.

## 1.1. Draft Window & Withdrawals

- 1.1.1. Your Draft can only be made and changed during the official Draft Window.
- 1.1.2. At the End of Draft Window, all selections in the Draft become locked, with no changes possible.
- 1.1.3. If a drafted Fighter withdraws from OKTAGON Tournament during the Draft Window, you have until the End of the Draft Window to amend your Draft.
- 1.1.4. If your drafted Fighter withdraws, is otherwise unable to participate, is replaced, or the scheduled fight where the drafted Fighter should have participated is cancelled after the End of the Draft Window, you will automatically receive 1 point for that Fighter as a compensation.
- 1.1.5. It is your responsibility to ensure that your Draft is up to date before the End of the Draft Window. If you do not replace the withdrawn Fighter within this period, the slot will remain empty, and you will lose the opportunity to use it for that OKTAGON Tournament.

## 2. Scoring System

### 2.1. Fighter Draft Points

2.1.1. For each Fighter in a Draft, depending on the official results of the OKTAGON Tournament, you will receive the following number of points.

DRAFTED FIGHTERS' MATCH RESULT	POINTS GAINED
Win by KO	+5
Win by Submission / Win by TKO	+4
Win by Decision	+3
Draw / No Contest	+2
Loss	+1

1.1.2. For the purposes of OKTAGON Fantasy, the official result of your drafted Fighter's fight, including the method of victory, will be published on the official OKTAGON website.

1.1.3. The results published by OKTAGON on its official website shall be final and binding. OKTAGON may, at its discretion, adjust these results to reflect any corrections or amendments made by the official referees.

## 1.2. Win Method Bonus (Optional)

1.2.2. For each OKTAGON Tournament, you may choose to predict the method of victory (KO/TKO, Submission, or Decision) for one (1) of your drafted Fighters (the "Win Method Bonus"). This is optional: if you do not make a prediction, no bonus or penalty will apply.

WIN METHOD PREDICTION	BONUS POINTS
Correct Win method (fighter wins)	+2
Incorrect Win method (fighter wins)	-1
Fighter loses	No effect

## 4. Points Adjustments

4.1. To ensure fairness, OKTAGON reserves the right, at its sole discretion, to award the **Momentum Bonus** to Players who join OKTAGON Fantasy after the end of the second OKTAGON Tournament of the Season. The purpose of Momentum Bonus is to give late-joining Players a fairer chance to compete with those who started earlier in the season.

4.2. The Momentum Bonus is subject to the following conditions:

4.2.1. It applies only once per Player;

4.2.2. It cannot be awarded to Players who registered before or during the second OKTAGON Tournament of the Season.

1.1. Only one Player can reach and be crowned “**Champion**” each season. If two (2) or more Players finish the season with the same total number of Points, the Champion will be determined according to the following tie-break criteria, applied in order:

1.1.1. The Player who reached the tied Points total first in time.

1.1.2. The highest number of correct Win Method Bonus predictions.

1.1.3. The highest number of fights correctly predicted as KO/TKO victories.

1.1.4. The highest number of fights correctly predicted as Submission victories.

1.1.5. The earliest date of registration in OKTAGON Fantasy (the Player who joined earlier in the season).

1.2. If the tie is still not resolved after applying all criteria, OKTAGON will conduct a random draw between the tied Players. The result of this draw will be final and binding.

## 6. Leagues

## 6.1. General Provisions

6.1.1. In addition to the main OKTAGON Fantasy competition, OKTAGON may offer optional league formats (the “**Leagues**”) as described herein. Participation in any League is voluntary and free of charge. Each League operates independently with its own leaderboard and set of Rewards. Unless otherwise specified, all other provisions of these Rules apply to Leagues.

## 6.2. League Drafts

6.2.1. A League may use the Player’s main OKTAGON Fantasy Draft for the relevant OKTAGON tournament, or may allow or require a separate League Draft, as specified in the applicable League Rules.

6.2.2. Where a separate League Draft is used, such League Draft applies only to the relevant League and does not affect the Player’s main OKTAGON Fantasy Draft, Season ranking, Rank progression or main Season Points, unless expressly stated otherwise.

6.2.3. A League Draft may be created by copying the Player’s main Draft and may be edited separately during the applicable Draft Window, where permitted by the relevant League Rules.

6.2.4. The Draft Window and End of Draft Window applicable to the relevant OKTAGON Tournament also apply to League Drafts, unless expressly stated otherwise. After the End of the Draft Window, no changes to a League Draft are allowed.

6.2.5. OKTAGON may determine, for each League, whether a Player must first create a main OKTAGON Fantasy Draft before joining or participating in that League.

## 6.3. Fighter Slots and Season Rank Benefits in Leagues

6.3.1. Season Rank benefits, including the 4th Fighter selection slot unlocked at Rank “Contender”, apply to main OKTAGON Fantasy Season only, unless expressly stated otherwise in the applicable League Rules.

6.3.2. Each League may define its own Fighter Selection limit. A League may use a fixed number of Fighters for all Players, regardless of the Player’s Season Rank.

6.3.3. Where a League uses a fixed Fighter selection limit, Players must comply with that limit even if they have unlocked additional Fighter slots in the main OKTAGON Fantasy Season.

## 6.4. League Points

6.4.1. Points in a League are calculated to the scoring rules specified in the applicable League Rules. Unless expressly stated otherwise, standard OKTAGON Fantasy scoring applies.

6.4.2. League Points count only toward the relevant League Leaderboard and do not replace, modify or reduce the Player's main OKTAGON Fantasy Season Points.

6.4.3. OKTAGON may determine for each League whether Points from OKTAGON Tournaments that occurred before the Player joined the League will count retroactively toward that League.

6.4.4. Any retroactive scoring rules must be stated in the applicable League Rules.

## 6.5. League Rewards, Achievements, Avatars and Badges

6.5.1. Leagues may include League-specific Rewards, achievements, avatars, badges, digital items, access rights, prize draws, partner benefits or other promotional benefits.

6.5.2. League-specific Rewards are separate from main OKTAGON Fantasy Season Rewards, unless expressly stated otherwise.

6.5.3. League-specific Achievements, avatars, badges or benefits apply only within the relevant League or OKTAGON Fantasy environment.

6.5.4. OKTAGON reserves the right to modify, substitute, withdraw or replace any League Reward in accordance with these Rules.

## 6.6. Partner Leagues

6.6.1. OKTAGON may, from time to time, offer co-branded Leagues in collaboration with third-party partners (the "**Partner Leagues**"). The following conditions apply to Partner Leagues:

6.6.1.1. Participation in a Partner League is voluntary and free of charge.

- 6.6.1.2. Entry to a Partner League may be subject to the Player fulfilling certain requirements related to the partner brand, including subscribing to a newsletter, following social media accounts, making purchases from the partner, or other similar actions as specified by OKTAGON.
- 6.6.1.3. Each Partner League has its own dedicated leaderboard, which determines the Player's eligibility to receive Rewards within that Partner League.
- 6.6.1.4. Rewards available in each Partner League are specific to that League and are separate from the main OKTAGON Fantasy Rewards.

## 1.1. Celebrity Series Leagues

1.1.1. OKTAGON may offer Leagues in connection with Celebrity Series matchups (the “**Celebrity Series Leagues**”). The following conditions apply to Celebrity Series Leagues:

- 1.1.1.1. Participation in a Celebrity Series League is voluntary and free of charge.
- 1.1.1.2. Entry to a Celebrity Series League may be subject to the Player fulfilling certain requirements, which may be related to the main sponsor of the relevant Celebrity Series matchup or other conditions as specified by OKTAGON.
- 1.1.1.3. Each Celebrity Series League has its own dedicated leaderboard, which determines the Player's eligibility to receive Rewards within that Celebrity Series League.
- 1.1.1.4. Rewards available in each Celebrity Series League are specific to that League and are separate from the main OKTAGON Fantasy Rewards.

## 1. Fair Play & Conduct

### 1.1. Community Standards

1.1.1. Players must not engage in disrespectful, abusive, hateful, discriminatory, harassing, defamatory, fraudulent, or otherwise unlawful behaviour toward OKTAGON staff, fighters, or other Players. Players who violate this rule may be banned without prior notice.

1.1.2. Any content uploaded, posted, or transmitted in relation to OKTAGON Fantasy must not:

- 1.1.2.1. Infringe any third-party intellectual property rights.
- 1.1.2.2. Contain viruses, harmful code, or any form of malware.
- 1.1.2.3. Include offensive, hateful, violent, or obscene material.
- 1.1.2.4. Contain spam, advertising, political campaigning, or promotional content unrelated to OKTAGON Fantasy.

## 1.1. Anti-Cheat

1.1.1. Players must compete fairly and must not attempt to cheat, manipulate outcomes, exploit bugs, or coordinate unfair strategies. Cheating includes, but is not limited to:

- 1.1.1.1. *Multi-accounting* – Creating or using more than one (1) Account per individual.
- 1.1.1.2. *Account sharing* – Allowing another person to access, control, or use your Account.
- 1.1.1.3. *Bot use or automation* – Using scripts, bots, or automated tools to influence selections, predictions, or results.
- 1.1.1.4. *Collusion / coordinated gaming* – Exchanging information or collaborating with other Players to manipulate outcomes or leaderboards.
- 1.1.1.5. *Impersonation / false identity* – Pretending to be another Player, misrepresenting your identity, or manipulating rankings under a false name.
- 1.1.1.6. *Exploiting bugs or glitches* – Using technical errors or vulnerabilities in OKTAGON Fantasy to gain unintended advantages.
- 1.1.1.7. *Spam or disruption* – Flooding the OKTAGON Fantasy with unnecessary actions or communications that disrupt normal gameplay.
- 1.1.1.8. *Data manipulation / unauthorised access* – Attempting to hack, tamper with, or gain unauthorised access to OKTAGON Fantasy systems, databases, or information.

## 1.1. Leaderboard Names

- 1.1.1. Your “**Nickname**” (as the Player) will be displayed in the Leaderboard. Nicknames must be respectful and must not be offensive, misleading, or infringe the rights of others.
- 1.1.2. OKTAGON reserves the right to edit, require you to change, suspend, or delete any Nickname it deems inappropriate, regardless of a Player’s opinion. Examples of inappropriate Nicknames include (but are not limited to) those that:

## 2. Rewards & Redemption

### 1.3. Basics

- 1.3.1. Rewards are strictly non-cash and promotional in nature.
